

MINUTES OF THE 1ST MEETING OF THE STATE LEVEL HIGH POWERED STEERING COMMITTEE CONSTITUTED FOR STEERING THE PROPOSALS AND IMPLEMENTATION OF SMART CITIES MISSION AS NOTIFIED VIDE NO.DUD/Smart City -06/2015-16 DTD. 9TH JULY 2015.

Pursuant to the Circular, circulated vide No.DUD/Smart City-06/2015-16/6883-96 Dated 16th July 2015, the 1st meeting of the State Level High Powered Steering Committee, constituted for steering the proposals and implementation of Smart Cities Mission was held on 30th July 2015 at 10 AM under the Chairmanship of Chief Secretary, Govt. of Arunachal Pradesh at Conference Hall of Chief Secretary, Banquet Hall, Itanagar.

The list of participants are appended herewith as Annexure – 'A'.

The Chief Engineer-cum-Director, while briefing the objectives of the meeting has also highlighted the criterion for selection of a City/Town as Smart City and also defined a Smart City. He stated that only one city could be selected from Arunachal Pradesh as Smart City and in order to select a city all ULBs have been directed to prepare the Existing Service Levels. Accordingly, the reports on Existing Service Levels submitted by ULBs have been computed and placed before the Committee for examination and subsequent selection for making recommendation to Govt. of India.

The Secretary, PHE&WS, while participating in the meeting has opined that it would be better if a town having scope for future growth/expansion could be selected as Smart City.

After going through all the reports on Existing Service Levels as submitted by ULBs, the Committee has decided to recommend the following town for submission to Govt. of India by filling-up the Form – 1 for their further examination and selection as Smart City.

(i) Pasighat

Besides, above, the Chief Secretary, while assessing the present scenario of garbage management, landfill site, compost plant, drainage system and crematorium of Capital Complex has desired that top priority must be given to all these aspects and urged the Department to prepare plan and proposal so that allocations could be made as and when untied fund from Govt. of India as recommended by Fourteen Finance Commission is received.
